

Dear Prayer Partner,

While I have your attention, let me please share a few NEW prayer needs of a CRITICAL nature.

1. **Dave's Mom, Barabara Purnell**, was operated on Monday Oct. 31st. She had a tumor removed from her spine, but the cancer is also in other parts of her body. We are still awaiting the recommended treatment from the oncologist. She is struggling with severe pain in her back, and needs prayer for healing and strength. Please pray with us concerning when Dave should travel to be with her and his siblings.
2. **The leader of our Dear Ministry**, Pastor Mauricio Rojas, with whom we have served for these 11 years in the New Life B.Ch, in a very sudden way, just dropped on us without any previous discussion or mention, that he and the deaf were separating from our Church. This choice has not been preceded by any previous planning, prayer or discussion with the Church leadership. We are seeking to find a resolution to this issue. Please pray for God to be glorified and His church to be protected.
3. Pray for the **Occupancy Permit process**. We will submit the over 30 pages of documents to the independant reviewers on Monday, Nov. 14th, Lord willing. Then after they check all the documents, our architect will present the request for occupancy as soon as possible after that. **WE NEED TO BE IN OUR BUILDNG ASAP!! Please pray with us that God makes it happen....SOON!**
4. Not having been able to find a reasonably inexpensive solution to the broken windows (been looking for 6 weeks), we will soon need to have the 8 large panels of glass replaced. At the same time, we plan to cover or protect them, but that measure will be costly. All in all, the replacement of the glass and the protection will cost over \$5,000.00. This is not at all considered in our budget, and will detract funds from the other work we are doing for the occupancy permit. Pray that God in His grace provide the money needed, since the city will NOT allow us occupy the building with the broken glass that runs from the first to the third floors on the front of the building.

Thank you for prayer! And one more thing: **Dave was in the hospital 2 days** with arrhythmia that was oiut of control. The cardiologist ran three tests and found no damage or mechanic issues with his heart. The arrhythmia was caused by stress most likely. So, now Dave is shortening his work schedule and is on two medications for the arrhythmia. We are learning to rest in His arms...and to work within our limits.
